- 2. Implementation:
 - a) In order to carry out the above -mentioned activities, detailed plans of the academic cooperation, strategies for the interactions and mechanisms.
 - b) Both institutions shall agree to seek financial support for mutually agreed cooperative activities defined as above from appropriate agencies.
 - c) This agreement will effective for five (5) years after the date of signing. This Agreement is renewed automatically as long as neither party gives notice of termination to the other.
 - d) The notice of termination of this Agreement needs to be given well in advance, i.e., six (6) months in advance.
- 3. Confidential Information

Each party shall at all times during the term of this Agreement and for a period of five (5) years after keep confidential any conditional information received from the other party. Such confidential information will not be disclosed to any person, other than employee who needs to know for the purpose of performing their functions, without the consent of the owner of the confidential information.

4. Return of Confidential Information

Upon termination of this agreement for any reason, the parties shall return all confidential information to the owner.

5. Cooperative Research and Intellectual Property

Either party to this Agreement may purpose to the other specific individual research projects for collaboration. Such proposals may be made at any time and an individual project agreement will be drafted for each research project. The projection and exploitation of any valuable property arising out of a research project will be addressed in each individual project agreement.
