Whereas the BV's, Matoshri Byabai Shripatrao Kadam Kanya Mhavidyalaya, Kadegaon, Dist-Sangli has agreed to use SUCLA services, facilities, guidance and resources and promote and share its library resources with other members of SUCLA.

## Objectives of the MOU

The objectives of the MOU are:

- To promote and enhance academic interest through library services.
- To create common digital platforms to share institutional resources
- To provide guidance regarding new trends in LIS.
- To promote research / continuing education/extension activities betweencollege & Association.
- Provide support and training to the library staff.

- To provide and access library resources, e-resources and reading material.
- Provide necessary help in organizing workshop/conferences and seminars.
- To share bibliographic details books available in library.
- Create and participate in online Union Catalogue Server and future library application.
- Development of Library OPAC

#### **Terms and Conditions**

### Resource Sharing and Networking

- 1. This MOU is for next five years from date of signed by the authority.
- 2. Both Parties agreed to help, identify and invite the faculty members and subject experts to participate in conferences, workshops, seminars and training sessions.

- Institutional library and Association must be made available their resources for each other abiding the rules and regulations of concern authority/institution/library.
- If any book or document will be taken for lending purpose under resource sharing initiative then barrower authority will be responsible to pay necessary charges as per the rule of concern authority/institution/library.
- In the case of damage to resources borrowed from authority/institution/library, borrower authority/institution/library will be solely responsible for that damage.
- The college librarian will be responsible and acting as nodal person for co-operation and implementation of this agreement.

# Union Catalogue Server

- Participating institute library must be shared his catalogue with bibliographic descriptions as per the format given by the SUCLA.
- SUCLA will be develop the Union Catalogue Server and share the library catalogue in behalf of institution.
- SUCLA will be create and provide library OPAC of concerning institute library, which will be available online.
- Concern institute will be responsible for updating bibliographic details of library books time to time, SUCLA will provide the technical assistance & guidance todo same.
- 5. Institute library has to pay Annual Membership/ Subscription Fee Rs. 1200 annually to SUCLA for the use and maintenance of UNION CATALOGUE SERVER and LIBRARY OPAC in advance on or before 1st OCT of each year.
- Institute Librarian is responsible for providing library catalogue details to SUCLA for Union Catalogue Server.
- Institute can use the weblinks of UNION CATALOGUE SERVER & LIBRARY OPAC on his
  website.
- The Institution/college shall not be entitled to assign, sub-license or otherwise transfer the license whether in whole or in part to any other user.
- 9. The Institutional Member shall not use the SUCLA Union Catalogues for any commercial purpose. The Institution shall not rent, sell or license the use of or deliver or release or otherwise part with the possession of the systems/materials/software or any part thereof to any third person.

#### Termination of MOU

This MOU may be terminated by immediate notice in writing if SULA or the Institution has been responsible for a breach of its obligations and terms of this agreement. In such a case, the Institution shall stop the use of the SULA system facilities and databases with immediate effect and return any resources/material/software/hardware provided by or through SUCLA back to SUCLA. All disputes between the parties shall be settled by negotiation. SUCLA or Institution shall terminate the contract with a month's notice to the other party.

In witness whereof the parties to this MOU through their duly authorized representatives have executed this MOU on the days and dates set out below and certify that they have read, understood and agreed to the terms and conditions of this MOU as set forth herein.

The effective date of this MOU is the date of the signature last affixed to this Memorandum of Agreement. It is valid for the period of next five years.
