

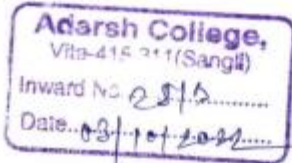

Memorandum of Understanding

Between

ADARSH COLLEGE, VITA

and

MATOSHRI BAYABAI SHRIPATRAO KADAM KANYA MAHAVIDYALAYA, KADEGAON

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this the Monday DAY of 10/10/22 DATE. **Adarsh College, Vita** and **Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalya, Kadegaon** therefore agree to establish a programme for academic cooperation in the areas of mutual interest, and in accordance with terms and conditions set forth in this MoU.

▪ **Background**

It is the statutory object of **ADARSH COLLEGE, Vita** to disseminate and advance knowledge by providing instructional, research and extension facilities in various branches of learning as it may deem fit and it shall endeavour to provide students and teachers the necessary atmosphere and facilities for the promotion of-

- Innovations in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality
- Studies in various disciplines
- Inter-disciplinary and multi-disciplinary studies
- National integration, secularism and international understanding

▪ **Purpose and Scope**

1. Both the institutions intend for this MoU to provide the foundation and structure for any and all possibly binding agreement related to academic, professional, research and extension activities and cooperation.
2. This MoU should not establish or create any type of formal agreement or obligation. Instead, it is an agreement between the institutions to work together in such a manner to encourage an atmosphere of collaboration and alliance in the support of an effective and efficient partnership to establish and maintain objectives and commitments with regards to all matters related to academic, professional, research and extension activities.

▪ **Objectives**

The goal is to foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions. **Adarsh College** and **Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalya, Kadegaon** agree:

- a) To exchange information on research and educational programmes
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research programmes
- c) To jointly organize short-term continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein
- d) To jointly organize seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein
- e) To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein
- f) Collaborations in the sharing of academic data, scientific information, intellectual property, articles and publications
- g) To exchange, on a reciprocal basis, students at Undergraduate and Graduate levels for limited periods of time for purpose of education and/or research.

Adarsh College, Vita and **Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalya, Kadegaon** agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two

institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

▪ **Exchange of Students and Teachers**

1. Reciprocal arrangements based on mutually acceptable terms shall be accomplished to give an impetus to collaborative research and joint projects. Teachers, researchers, guides, and students of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both the institutions.
2. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated and shall vary according to the rules, regulations and policies of every institution.

▪ **Joint Conferences, Workshops and Short-Term Courses**

Both the institutions agree to help identify and invite faculty members from the other institution to participate in conferences, workshop and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between **Adarsh College, Vita** and **Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalaya, Kadegaon**

▪ **Intellectual Property**

Both the institutions agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

▪ **Co-ordination**

Each institution shall appoint one member is its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of Director/President or his/her nominee/ Programme Coordinator from both the sides will periodically review and identify ways to strengthen cooperation between the two institutions.


▪ **Tenure and Termination**

This MoU will take effect from the date it is signed by representatives of the two institutions. It will remain valid for five years, and may be continued thereafter after suitable review and agreement. Either institution may terminate the MoU by giving written notice to the other institution six months in advance. Once terminated, neither **Adarsh College, Vita** nor **Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalaya, Kadegaon** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both the institutions will ensure that all activities in progress are allowed to complete successfully.

▪ **Arbitration Clause**

Should there be a dispute relating to any aspect of academic cooperation, Heads or Programme Coordinators of both the institutions will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

This MoU is signed subject to approval of the respective academic/administrative bodies.
