Statutory Declaration on Right to Information (RTI) Act 2005


Section 4(1) (b) of RTI Act 2005 covers the statutory declaration of Bharati Vidyapeeth's Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalaya Kadegaon, Dist.Sangli Website. It covers all the rules and regulations which are implemented by Government of Maharashtra.

Our college is a 'women college' which is registered under society act by Govt. of Maharashtra and affiliated to Shivaji University, Kolhapur (MS). The college has a governing body which is approved by the authority appointed by govt. of Maharashtra. It runs as per rules and regulations made by the Govt. from time to time.

The college comes under 'Grants in aid' category; therefore financial transactions are audited by the government. The college has different bodies to maintain all types of disciplines in the campus.
