1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The institution Bharati Vidyapeeth's Matoshri Bayabai Shripatrao Kadam Kanya Mahavidyalya, Kadegaon is established in 1990 especially for the education, welfare and empowerment of the girls in this rural area. It was named after the mother of Dr. Patangrao Kadam, the founder of Bharati Vidyapeeth. The Institute runs the undergraduate courses in Arts, Science and Commerce, post graduate courses in Marathi and Botany and Ph.D. course in Microbiology, Botany and Physics, affiliated to Shivaji University, Kolhapur. Faculties in the subjects of Chemistry, Botany Zoology, Physics, Microbiology, Marathi and Commerce are also recognized as research guides for M. Phil and Ph.D. by the Affiliating University.

The location of the Institute is very attractive and of academic impression. The educational complex is very safe and useful for the girl students for their career making. It is unique center in Western Maharashtra for girl's education. Its quality education has been already certified by NAAC in 2012 - 'A' grade with CGPA of 3.13 (Second Cycle) and in 2017 'A' grade with CGPA of 3.21 (Third Cycle) during its re-accreditation process. It has been ranked 99th in the NIRF ranking -2017 and 63rd in the ranking made by National Magazine 'Career 360' in 2016. The Institute has also been awarded 'Indira Gandhi Best NSS Unit Award' and 'The Best NSS Programme Officer Award' by the Govt. of India.

The institution is endeavoring to pursue the high standard of education to students. The Institute is conscious about the socio-economic background of its students. During its formative period, the majority of students were from villages. Their parents were mostly illiterate. Therefore, the institute aimed to discipline the minds of these students and make them aware about the competitive nature of the world. During the last 32 years, the institute has developed excellent infrastructure facilities in terms of building, laboratories, library, hostels, gymkhana, play ground, auditorim etc.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The institute is affiliated to Shivaji University, Kolhapur and it follows the University designed curriculum. The institute operates at UG and PG level and it has a wide range of programme options that includes B A in five subjects, B.Sc. in four subjects, M.Sc. in Botany, M.A. in Marathi and Ph.D. in three subjects as well as skill oriented and value added courses. Among these the post graduate, Ph. D., career oriented and skill oriented courses have been newly started since last re-accreditation. Our faculty is actively involved in the development of the curriculum by affiliating University. Two faculty members have been worked as the members of Board of Studies, five members have been worked as the members of syllabus formation committee, five as resource persons in the workshops on draft syllabus and nearly all are the participants of workshops on syllabus revision.

The institute has conducted 72 Value Added/ Certificate courses during the last five years. Beside this 587 students have completed Project Work and Intermship in last academic year.

Besides this, the institute has organized two workshops on revised syllabus. The faculty has also been involved in the development of syllabus of other Universities, designed the curriculum for Career Oriented and Skill Oriented courses. The curriculum is effectively implemented through academic calendar, time table, teaching plan, teaching completion reports, and feedback from the students. Efforts are taken to increase the subject knowledge through lead lectures, guest lectures, study tours, industrial visits, projects, seminars, group discussions etc. The entire process of curriculum transaction is monitored by the head of the departments and Principal through academic diary and feedback. The execution of the curriculum is annually reviewed by the IQAC. For all undergraduate and postgraduate courses semester system is followed. The Choice Based Credit System (CBCS) is implemented for all courses from 2018 by the affiliating University and NEP 2020 is introduced for First year of UG and PG courses from 2022-23.

Teaching-learning and Evaluation

The institute follows transparent admission procedure. Its publicity is made through the institute prospectus, website, print, electronic media and informal communication with alumni as well as present students in the institute. The rules and guidelines given by the government and university are strictly followed. The admission of PG courses are done at the University level while the admissions of career oriented and adult & continuing education courses are done at the department level. Efforts are taken to avail various types of government freeships for SC, ST, NT, OBC, Minority, Ex-Servicemen, and differentially abled students. Extra knowledge resources are made available to advanced learners and remedial coaching is given to the slow learners.

The teaching – learning process is made more student-centric by promoting the use of ICT enabled classrooms, virtual lectures and e-resources. Huge numbers of reference books are added in the library and INFLIBNET,

NDL is made available for the students and staff. Critical thinking among the students is nurtured by promoting them to participate in competitions on essay writing, elocution, debate quiz, group discussions, etc. The Institute has well experienced, highly qualified (18 Ph. D. holders) and research oriented faculty members. Nine faculties are research guides and two major and seven minor research projects have sanctioned and completed by the faculty.

The faculty also contributes in the examination system of the affiliating university as well as other universities. Earn and Learn scheme, concession in hostel fee is made available to the needy students. The students are monitored through the records of daily attendance, academic performance, parent meet etc. Attendance of students is strictly monitored and defaulter student's guardians are notified and informed to discuss and troubleshoot the problem. The teachers are also constantly monitored through feedback from students, API, academic diary. If required, proper counseling is made available to the faculty. The effectiveness of teaching learning process is reflected by the academic performance of the students. Mentor- mentee scheme is effectively implemented. CO and PO are displayed on the website and also discussed with the students in classroom. Attainment of CO PO are calculated at the end of every academic year.

Research, Innovations and Extension

The institute is aware about the importance of research in higher education and it has a Research Committee to monitor and address the issues of research. The faculty is actively involved in research activities. Nine faculties are recognized as research guides by the University and they are providing guidance to the scholars.

Infrastructure and Learning Resources

The creation and enhancement of infrastructure is consistent with the needs that come up as a result of academic development. The institute has huge buildings sufficiently well equipped in terms of physical infrastructure for existing academic programmes and administration. The enough infrastructures for both indoor and outdoor games are available. The gymnasium is equipped with indoor games such as Table Tennis, Carom and Chess, Basketball court. The total area of the playground is 19,800 Sq. meters. It has 8 lane 400 meter standard track ,badminton courts for the game of Kho – Kho, Kabbaddi, Volley ball, Hand ball, high jump mat with bar & stand and single court for football, jumping pit .

An auditorium having area of 488.00 Sq. Meter with 270 persons seating capacity for the organization of cultural and other extracurricular activities are available. The institute provides hostel facility for the students. It has well furnished rooms with beds, tables, chairs and cupboards, attached bathrooms and toilet , spacious dining hall , constant water supply, vending machines, safe drinking water through water purifiers, solar system for hot water , recreational hall with television, 24 hrs special security through private security services ,CCTV camera to ensure safety etc. The library is fully computerized and atomized by using e-granthalaya software. OPAC is also provided for searching the books. Access to e- Books and e-journals is made from INFLIBNET and NDLI.The barcode system is used for effective and speedy transaction of books. User Tracker system is used in library.

The internet facility is available for the faculty and students. Wi-Fi facility is made available in the campus. The computers in the Language Lab, library, administrative office, various departments and laboratories are connected with high speed internet facility. The enough number of computers, laptops, LCDs, are available for teaching learning process. The management and administration is insisting faculty for the use of computer aided teaching / learning process. Provission is made in the budget for maintance of Physical and Academic facilities and it is made regularly as per the need.

Student Support and Progression

In the student support, scholarships and free ships have significantly impacted the institution's students over the past five years, benefitting 61.48% (3239 individuals) with a total value of ?9,393,248, showcasing a commitment to educational accessibility. The institution focuses on comprehensive capacity development through targeted activities, fostering language, life, and ICT/computing skills.

Guidance for competitive exams and career counseling has reached 40.07% of students, reflected in initiatives like "Competitive exam guidance & it's changing prospects" and specialized workshops. This commitment to nurturing competitive exam readiness and career advancement is evident in varying student numbers across academic years. For grievance resolution, the institution employs guidelines, awareness initiatives, submission mechanisms, and dedicated committees to address issues such as sexual harassment and ragging.

In student progression, 46.28% of outgoing students secured placements or advanced to higher education in the last five years. This commitment to diverse pathways is evident in annual figures: 160 (2022-23), 163 (2021-22), 99 (2020-21), 119 (2019-20), and 131 (2018-19) students, against respective total outgoing students.

Regarding student achievements, 2.44% excelled in state and national exams over five years, with 19 students showcasing academic excellence. The institution's focus on fostering academic achievement is demonstrated through consistent success.

Over the past five years, sixty seven awards and medals have been received to students and students have actively participated in an average of 33.2 sports and cultural events annually. In 2022-23, they engaged in 52 events, including University Zonal competitions in Kho-Kho and Athletics. In the previous year, 2021-22, participation reached 29 events. Despite pandemic challenges in 2020-21, students participated in 8 events. In 2019-20, they took part in 39 events, and in 2018-19, participation extended to 38 events. These activities underscore the institution's commitment to holistic education and students' active engagement beyond campus boundaries.

Alumni engagement is a key focus, with the registered Alumni Association actively contributing to the institution's development. Annual meetings, online communication, and collaborative events bridge academia and the corporate world. During five years 158 faculties have participated in Refresher Course, Orientation and Faculty Development Programs. The institute has provided financial support for attending conferences, seminars and workshops.

The parent institute reviews comprehensive academic and administrative aspects of the institute to fulfill the mission. The parent institute takes immediate steps to meet necessary changes and improvement whenever necessary. IQAC formulates the action plan for the fulfillment of policies regarding the mission. Participative management is ensured through CDC, IQAC and different committees.

Institutional Values and Best Practices

Institute provides about 10 curricular and 29 co-curricular activities for gender sensitization and equity, as well various safety facilities for women. For green initiative in campus and beyond campus various environmental promotional activities are undertaken. Green and environmental audits are conducted through recognized agencies. Green and clean policy, plastic free policy as well barrier free environmental policies are prepared and displayed accordingly activities strictly implemented, hence receives award from Kadegaon Tahsil and appreciation from NSS adopted villages for noteworthy activities.

During the Covid -19 Pandemic, sensitization of students and peoples are made to protect from corona virus disease through the activities of vaccination, cleanliness campaigns. The institute distributes Mask and sanitizer, Gender sensitization and *Beti-bacho abhiyan*. Institute provides many facilities to implement these programs. Through statutory committees like Anti-sexual harassment cell, Anti-ragging cell, Grievance redresser cell, NSS, Gymkhana etc various extension activities are carried out like workshops on Women's law, *Mahila Melawa*, lectures on health, nutrition, fitness training, yoga training, safety majors to support girl students.

As per the vision and Moto of our founder member the institute works in different sectors of society. Every faculty with different aspect reaches in the society to aware the people are great task. Educational awareness like book donation, identification of plant diseases, Ethanomedicinal plants, QR coding of plants, biodiversity studies, awareness of programm vocabulary and carrier counseling in English language, digital literacy program etc. organizes for villagers and stakeholders. For health awareness, yoga training, blood group detection campaigns and awareness of sound pollution in young generation are undertaken. Faculty contribute in environmental awareness program like soil analysis, water analysis, food adulteration, effect of pesticides, organic farming, bird feeding projects etc. were noteworthy activities. The programs like digital literacy, women empowerment, human right, project on problems old age people and domestic violence were social contribution of faculty. Besides this through NSS committee several extension activities were carried out which get appreciated by the society.

1.1 Curricular Planning and Implementation

1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The effective curriculum implementation is the key to success for any academic institute. The institute implements the curriculum prescribed by Shivaji University, Kolhapur. The department heads are provided the copies of the curriculum implemented by the BOS in the related subject of Shivaji University. Before the commencement of each academic year, the concerned department heads plan the curriculum implementation strategies with the help of other faculty members. Institute timetable committee prepares the timetable for the entire institute. With the help of institute timetable, each department prepares its separate timetable and each faculty member prepares his/her individual timetable. The timetable is approved by the concerned department head and the principal.

For the effective curriculum delivery, the faculty members prepare their extensive and wellplanned curriculum teaching plan at the beginning of the academic year. The timetable committee ensures that the curriculum implementation should be according to the pre-decided objectives. The extracurricular activities, extensive work timetable, and examination schedule are taken into consideration while preparing the curriculum delivery plan by the timetable committee and department heads. A separate schedule of extracurricular activities, extensive work, and other students' related activities is prepared in well advance and it is taken into consideration while planning the teachinglearning strategies by the faculty members. At the end of each semester, the faculty members submit their syllabus completion report to the respective head and each head presents the department syllabus completion report to the principal. The department prepares its separate timetable for the advanced and slow learners. The planning of co-curricular and extra-curricular activities is considered while preparing the departmental timetable.

The institute has established separate committees for Academic Calendar and CIE. In the beginning of the academic year, the Academic Calendar Committee invites the planning from various departments, support services and committees. According to schedule of affiliated University, the committee prepares the academic calendar for various activities. The Academic calendar is displayed on display board and uploaded on website. It carries approximate schedules regarding admission process, teaching-learning schedule, evaluation, curricular and co-curricular activities, extra-curricular activities, major departmental and institutional events to be organized and dates of holidays. Continuous internal evaluation of students is made by conducting home assignments and unit tests. The CIE committee plans the Unit Tests, Home Assignment, Internal Tests, Seminars and Oral Exams of the students. CIE also monitors that the assessment is done accordingly. Examination committee works on slots reserved in academic calendar for internal evaluation and prepares and displays time-table. Each faculty of the departments prepare teaching plan considering the syllabus and examination schedules. Internal evaluation is carried out by organizing seminars, tests, projects, orals, group discussions, unit tests, home

assignment, project work, field work etc. For B.A., B.Com and B.Sc. Part III 20 percent marks are allotted for the internal evaluation. Question papers are set by concerned subject teachers on syllabus taught. Record of evaluation of tests is maintained at department level. Exam committee takes periodical review of CIE in each department.

Use of ICT in Teaching-Learning:

For effective curriculum delivery, ICT tools were used by faculties of all departments. The consistent use of ICT in teaching includes well configured Computers, Scanners, Printers, Webcam, LCD Projectors, and Smart Boards which enhanced learning experience of the students. The Institution is well equipped and is upgraded with ICT enabled Classrooms. It is also supported with Wi-Fi, INFLIBNET, E-GRANTHALAYA and subscribed e- resources and software.

Faculties used extensively the online platforms such as Zoom Meet, Google Meet, and Google Classroom to conduct the online lectures. The faculty members created Class – wise WhatsApp groups of the students. They prepared video lectures, PPTs, Quizzes, audio lectures and shared the same to the students on their respective WhatApp groups. Teacher also shared You-Tube videos, PDF files, Web links and other academically relevant e-resources to the students.

* The teacher assesses Units Tests, Home Assignments and returned these to the students with

suggestions for further improvement, if any.

* All the departments display the marks of students of internal assessment on the notice board.

* Question banks are prepared and made available to the student for better performance in the university examinations.

* Attendance of students is strictly monitored during university and college level examinations.

* Examination timetable is displayed on the notice board and college Website.

* Internal evaluation is conducted in view with the program and Course Outcomes.

* Internal squad is appointed to conduct the examination as per guidelines of the university.

2) External Assessment:

The university level examinations are conducted by affiliating university as per timetable declared in advance. The Institution conducts the examinations transparently as per rules and regulation of the university.

External assessment of first year U.G. students is done in institute by the faculty members of respective subject. For the assessment of the second and third year of U.G. students and first and second year of P.G. students is done by University through CAP Centers. The faculty members assess and moderate the answer papers in CAP Centers only. The process of assessment is made transparent by university itself through its strict mechanism.

3) Grievance Redressal System:

The Institution has developed efficient mechanism to curb the malpractices in the examination. The Institution has developed strong Mechanism. The Complaint Redressal Committee is formed to resolve student's grievances during university and college level examinations.

The program outcomes, program specific outcomes and course outcomes are published on the website and the copy of the same is duly signed by the principal, is kept ready in departmental file. The outcomes are further disseminated in the beginning of academic year and its meaning and context is further explained by each course faculty member during theory/practical work.

In the backdrop of the vision and mission of NEP, the Outcome Based Education (OBE) model focuses on student-centric education in order to develop the personal, social, professional, knowledge requirements in student's career and life.

The institution is affiliated to Shivaji University Kolhapur and the university syllabi mention course outcomes. The institution has already transformed from the traditional system to Outcome Based Educational system (OBE). The university frames and prescribes syllabi for all the courses. However, many teachers are involved in the process of update of university curricula to align with the latest knowledge requirements. The subject teachers of each department identified the Programme Outcomes, Programme Specific Outcomes and Course Outcomes. The teacher find out the outcome achieved considering their results and it is displayed on the institute website and on notice boards. Pedagogy is designed and used in teaching learning practices to achieve the learning outcomes. Suitable formative assessment is undertaken to test the achievement and aptitude levels of students. POs, PSOs and COs are calculated on the basis of direct and indirect methods. Response:

The course outcome attainment is assessed in order to track the student's performance with respect to the target level of performance. The CO-PO attainment is one of the tools used for continuous improvement in the student's abilities through appropriate learning and teaching strategies. In order to assess students' performance with respect to abilities the course outcome attainments are measured. The program outcome attainment measurement is based on the course outcome attainment.

The POs, PSOs and COs are listed on the website as well as maintained by the individual faculty in their course files.

PO attainment is calculated using direct and indirect method. Direct method indicates attainment by course outcomes contributing to respective program outcomes. Indirect method is the feed-back of students.

The basis of the attainment for OBE is the student's examination marks obtained from the examination section. In order to evaluate attainment of COs, different assessment tools (semester end examinations and laboratory examinations) are defined and developed. Several methods are introduced to measure the student learning.

Examples of PO, CO Attainment:

Course Attainment Levels: CO attainment is defined at three levels. It is based on internal and end term examination assessment. CO attainment is defined at three levels in ascending order. For end term and internal examination:

Level-1: 30% students scored more than class average

Level-2: 40% students score more than class average

Level-3: 50% students score more than class average

Target level defined as Level-2 indicates that, 40% students score more than class average. CO attainment is measured and the results are obtained. Based on the results of attainment, the corrective measures are performed or remedial action is taken.

CO Attainment= 80% (Attainment level in end term examination)

+20% (Attainment level in internal examination).

Program attainment Level: PO attainment is defined at five levels in ascending order. It is based on the average attainment level of corresponding courses (Direct Method) and feed-back survey (Indirect method). The PO attainment levels are defined as stated below:

1. Level-1: Greater than 0.5 and less than 1.0 (0.5>1)- Poor

2. Level-2:1.0>1.5-Average

3. Level-3:1.5>2.0-Good

4. Level-4:2.0>2.5-Very Good

5. Level-5:2.5>3.0 -Excellent

PO attainment target level say, Level-4, indicates that, the department is aiming at minimum level-4 (very good) in the performance of abilities of student's. Based upon the results of attainment, the remedial measures are taken. PO Attainment= 80% (Average attainment level by direct method) + 20% (Average attainment level by indirect method).

Two Major research projects received funding of Rs.5, 46,000/- from UGC, New Delhi & Rs.4, 96,198 received from minor research projects.

Response:

The institute is located with a beautiful, scenic background in 22.5 acres of land and the boundaries are demarcated by the compound wall. The institution has spacious campus for the purpose of organizing academic, sports, and administrative activities.

Classrooms and Laboratories: The institution has well-furnished classrooms and laboratories that are adequately ventilated. The specifics are as follows:

ICT Facilities: Computers are connected to the Internet using LAN connections. Wi-fi and Broadband internet connections are available with speeds of 100 Mbps. Along with Laptops, LCD Projectors, Screens, Printers, Scanners are also made available to the classroom, departments, laboratory, library, office and auditorium.

Library: The library has separate bulding and its size is 180. sqm. Carpet area. The library is completely organized, including a reading room, reprographic facilities, periodicals, E-books, and E-journals.

Cultural Room: A separate room has been provided by the institution that is equipped with musical instruments such as Tabala, Dholki, Dholak, and Harmonium for cultural activities.

Play Ground: The total area of the playground is 19,800 Sq. meters. It has 8 lanes 400-meter standard track, courts for the game of Kho-Kho, Kabaddi, Volley ball, Hand ball, Athletics (Field and track), High jump mat with bar & stand and single court for football, long jumping pit.

Gymnasium: The gymnasium is equipped with indoor games such as Table Tennis, Carom and Chess, Badminton courts, Basketball court with pavilion the eight stationed multi-gym with bar, plates, twister, bike and rowing machine, etc. The institution has a gym that has multiple stations that include chest presses, leg presses, leg extensions, leg curls, shoulder presses, bench presses, lat pulley's, pectoral decks, and double bars. It is also equipped with Bar Bell, Dumbbell, Power Lifting Weight Set, Gymnasium Mirrors, Weight Machine, Dumbbell etc. In indoor changing room is also available.

Auditorium– An auditorium having an area of 488.00 Sq. Mtr. with 270 persons seating capacity for the organization of curricular and extracurricular activities is available.

Botanical Garden: Botanical Garden has area of 464.51 sqm. and it has number of diverse floras.

Canteen: Canteen has seating capacity of 50 people.

Hostel: The institute provides hostel facility for the students. Health Care Centre in hostel building is also available. The details of the facilities and various provisions available are as follows:

The College is permanently affiliated to Shivaji University, Kolhapur and following the rules and regulations laid down by the Govt. of Maharashtra. The institute has well defined and stringent process for the mobilization and utilization of funds.

The College follows rules and regulations of Government of Maharashtra, and Shivaji University, Kolhapur in issues related with fee structure for various courses run by the college.

The College maintains account of all financial transactions. The fees collected through different course admissions and examinations are clearly mentioned in the cashbook and ledgers. The fees collected from students by way of different un-aided courses are used by the College to meet expenditure incurred on these courses as well as augmentation of physical and academic facilities. The College makes optimum use of infrastructure, library and human resources.

Internal Quality Assurance Cell (IQAC) has contributed significantly to institutionalizing the quality assurance strategies and processes. IQAC of the college has active contribution for the quality enhancement by continuous improvement in all working areas of the institution by connecting students, teachers, parents, management, alumni and society. IQAC monitors the implementation of vision and mission of the college. IQAC prepares perspective plan of development for the college and execute it in a strategic way. It has been trying to institutionalize number of quality assurance strategies such as digitization of academic and administration facilities, gender equality, strengthening extension activities etc. Such two initiatives are as follows,

IQAC has always been trying to enhance and update its academics and administration. The institute conducts various gender sensitization programs through different committees in terms of curricular and co-curricular activities. Statutory committees are displayed in the campus and emergency contacts are provided to the students.

Curricular Activities:

As our institute is only for the women the institute does not focus on gender audit. However gender sensitization is very sensitive issue and equity is serious problem of society. Accordingly Sociology department and Gymkhana committee take initiative for the *gender equity and gender sensitization* action plan and organizes value added courses about gender sensitization and gender equity and sensitivity related issues.

Co- curricular Activities:

Besides curricular activities many other co- curricular activities are run by other cells of institute like..

Anti-Sexual harassment, Beti bachao abhiyan cell and Ladies association:

During 5 years, these committees organizes programs like health awareness programs and lectures, fitness training, entrepreneurship development workshop and training of *Mehandi* making and *Rangoli* designing courses etc., through which students earn money. Committee organizes "*Save girl child*" campaigns, various lectures on health and hygiene, nutrition and domestic law etc. Gymkhana committee organizes self-defense workshop and yoga training to provide over all guidance to understand the social and cultural construction of gender and awareness in equality in law.

Anti-ragging Committee: It is statutory committee through which students are informed about the antiragging rules. Undertakings are taken from students and parents at the time of admissions. The online affidavits submitted by each students.

Grievance Redressel: If students have any problems they are free to compliant to this cell. Suggestion box is installed in library where students can put suggestions or their complaints.

Every faculty has its own extension activity through which social, economically, environmental, educational and medicinal i.e. health of society has changed and noteworthy.

Faculty contributes their work in society by engaging different outreach activities. Language departments like Marathi, Hindi, and English as well library department work in the educational field. For educational awareness they run awareness programs in nearby areas. Through department of Marathi Mrs. U.A. Desai and Dr. S.A. Mali donates books to the school children's. Mr. A. M. Yadav of history department undertook the program of Fort preservation and conservation, while Mr. H.S. Mane of Geography departments introduces knowledge of Agro tourism to the villagers.Healthy mind createshealthy people and healthy people makehealthysociety. Health cortisones have become a prime need of society since world health affected by Covid19. Considering this our institute actively contributes our efforts in this sector. During Covid 19 situation in 2020 also institute serve the society by availing the campus for Covid center as well the student volunteers work for the society. College distribute free mask, sanitizers to the students and people, organizes health checkup camps by Mr. S.S. Shinde of the department of Microbiology which concentrate on the women health, so that blood detection camps ore organized. Dr. U.K. Mohite has run Yoga training camp for Senior citizens in Mohite Vadgaon village which is very important activity to improve the health of people. In Kadegaon tehsil farming is main business, farmers use traditional methods e long ago, however some of the faculty is engaged in the awareness programs for the soil, water. Prof Dr. V. Y. Kadam implement the vermi-composting project in the college campus and aware the farmers for the use of vermi-composting to improve the soil fertility. Mr. J. V. Kuvar from Microbiology department undertaken the awareness program for improving oil fertility though microbes.

Department of chemistry organizes awareness program for farmers Dr. S.V. Pore and Mr A L More

undertake the Soil and Water Analysis program for students while Mr. S. N. Gotpagar aware the farmers for the use of pesticides in the field so that farmers are aware about the soil analysis and know the importance of use of pesticide and water quality parameters. Department of Botany has lab to field communication with farmers Dr. R. R. Jadhav help the farmers to identify the plant disease and control majors for the diseases .Dr. V. V. Naik teaches the Q. R. coding system of identification of plant which is very advanced technique of identification. Prof Dr. M. M. Ghatge has served the local medicinal plants used by *vaidues* from adjoining villages and identifies the plant and correct botanical name which can be used for the further assessment. Healthy environment keeps the society healthy, people must be aware about the environment. To keep the environment clean and healthy is the duty of each person accordingly environment awareness programs like sound pollution awareness has been undertaken by Mr. Ingwale H.R and global warming effect by Dr. C. E. Patil from physics department. Under the nature club committee Dr. Sunil Londhe of Zoology department every year organizes bird feeding activity for the birds during summer season in the college campus. Each of the faculty is involved in the social, economic, educational, environmental awareness program and offers the gratitude over the society.
